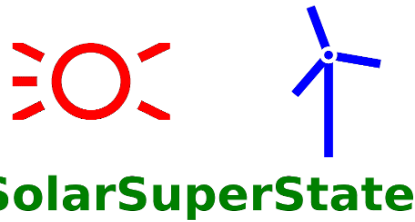

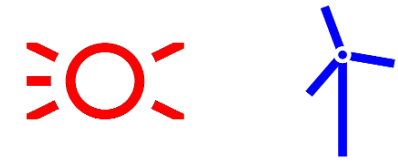

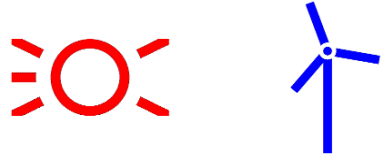

SolarSuperState

The SolarSuperState Association is the global voice of people and organizations that can benefit from rapidly increasing markets for decentralized renewable energy technologies (wind and solar energy, energy storage, ...) by:

- SolarSuperState Competition of all states
- SolarSuperState Ranking of all states
- SolarSuperState Prize for
 - * states (priority)
 - * regions and municipalities
- Request for all states
 - * 100 % renewable energy economy as fast as possible
 - * 100 % renewable electricity production relative to its consumption within 5 years

The outcome of the SolarSuperState Competition is described in the annual SolarSuperState Ranking with the categories wind (energy) and solar (photovoltaics). The SolarSuperState Ranking increases the transparency about the progress in renewable energies at the state level.

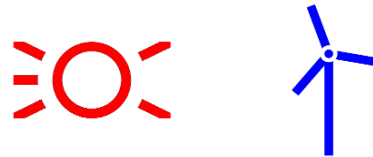
At the SolarSuperState Prize, states can learn from the best states about applied legal frameworks for a fast deployment of renewables, especially wind and solar energy. The SolarSuperState Prize encourages states to accelerate the deployment of renewables in order to get a SolarSuperState Prize in the future too.

The association requests from every state the early and total phasing out of fossil / nuclear energy usage.

SolarSuperState

Regarding the national consumption of energy, a SolarSuperState produces in an annual balance 100 % of its energy by national renewable energy:

- 100 % electricity from national renewable energy
- 100 % energy for heating buildings from national renewable energy
- 100 % national renewable energy in transportation and mobility
- 100 % industrial process heat from national renewable energy



SolarSuperState

In a SolarSuperState, renewable energies are not just one add-on to fossil and nuclear energy but the sole basis for energy.

A SolarSuperState still does not exist on the earth. A few states have already achieved some 100 % of renewable electricity production versus consumption. Uruguay is thereof the one with the highest share of wind electricity (2014 > 5 %, 2016 > 20 %). Especially wind and solar enable for 100 % electricity.

Therefore, it is still possible for every state to get the first SolarSuperState.
